**WHEREAS**, the County of Chatham has need for and intends install water lines along State Roads # 902 and #1139.

WHEREAS, the County of Chatham intends to request state loan assistance for the project,

# NOW THEREFORE BE IT RESOLVED, BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF CHATHAM OF GOVERNMENT:

That the County of Chatham will arrange financing for all remaining costs of the project, if approved for a State loan award.

That the County of Chatham will adopt and place into effect on or before completion of the project a schedule of fees and charges which will provide adequate funds for proper operation, maintenance, and administration of the system and the repayment of all principal and interest on the debt.

That the governing body of County of Chatham agrees to include in the loan agreement a provision authorizing the State Treasurer, upon failure of the County of Chatham to make scheduled repayment of the loan, to withhold from the County of Chatham any State funds that would otherwise be distributed to the local government unit in an amount sufficient to pay all sums then due and payable to the State as a repayment of the loan.

That the County of Chatham will provide for efficient operation and maintenance of the project on completion of construction thereof.

That Charlie Horne, County Manager, and successors so titled, is hereby authorized to execute and file an application on behalf of the County of Chatham with the State of North Carolina for a loan to aid in the construction of the project described above.
