The following was reported in the interim report dated December 1st 2017.

"From October 1, 2016 to September 15, 2017 the County of Chatham has expended a total of \$15,563.63 for services rendered in support of implementation of the N.C. Wildlife Resources Commission Green Growth Toolbox (GGT) project and Partners for Green Growth. Of the \$15,563.63, \$6,023.63 was provided in non-federal in kind match from Chatham County for work completed to date.

Of the \$15,563.63, \$9,540.00 was invoiced for reimbursement by NCWRC, for work completed to date. All work completed to date is described below in the narrative of work performed.

The non-federal in-kind match of \$6,023.63, \$3,997.55 consists of hours of county staff time completed to date and \$2,026.08 consists of volunteer time. The in-kind match hours documented for the NCWRC GGT project are not part of the amount of funds to be reimbursed by NCWRC and were not used as non-federal in-kind match for projects conducted by other organizations or NCWRC projects."

A final invoice was received from Land Design on October 10th 2017 for \$460.00 for the reimbursement for work completed on document revision. The purpose of this report is to serve as the concluding summary of the project, to update the information in bold as follows:

From October 1, 2016 to March 1, 2018 the County of Chatham has expended a total of \$16,023.63 for services rendered in support of implementation of the N.C. Wildlife Resources Commission Green Growth Toolbox (GGT) project and Partners for Green Growth. Of the \$16,023.63, \$6,023.63 was provided in non-federal in kind match from Chatham County for work completed.

Of the \$16,023.63, \$10,000.00 was invoiced for reimbursement by NCWRC, for work completed described below in the narrative of work performed.

The non-federal in-kind match of \$6,023.63, \$3,997.55 consists of hours of county staff time and \$2,026.08 consists of volunteer time. The in-kind match hours documented for the NCWRC GGT project are not part of the amount of funds to be reimbursed by NCWRC and were not used as non-federal in-kind match for projects conducted by other organizations or NCWRC projects.

The project deliverables are enclosed in a CD. This includes the final guidance document which presents justification for and details regarding step by step conservation planning and design process, study area map, and conceptual illustration. The CD also includes materials used at the Chatham County Conservation Partnership meeting such as the base maps used for the charrette, power point, and pictures taken at the meeting.

The final document and concepts are also referenced in the Chatham County Comprehensive Plan adopted November 20th 2017. It is also available online in the digital appendix of the Comprehensive Plan final document found at www.chathamnc.org/comprehensiveplan
