- 5 parents have graduated from the Parenting Matters class
- Continuing to do front porch visits and phone calls

Department of Public Safety Update

Juvenile Justice Statistics

- November 7 juvenile intakes from 13 complaints, 6 of which were approved for court, 1 youth in detention for 19 days, 6 on electronic monitoring for a total of 117 days
- December 3 juvenile intakes from 6 complaints, 1 of which was approved for court, 1 youth in detention for 31 days, 3 youth on electronic monitoring for a total of 91 days

- CIS has partnered with businesses and churches to distribute food and clothing and gift donations (Tych)
- RFP applicants can attend training on February 10th (Denise)
