The Chatham County Board of Elections met at the Chatham County Board of Elections office at 984 Thompson Street Suite D, Pittsboro, NC 27312 on May 18, 2021, at 5:30 p.m. via GoToMeeting. Citizens were given the opportunity to submit comments or concerns about precinct changes and other election related matters via email to the Director by 5:00 p.m. to be addressed during citizens input on the agenda.

The following people were present: Chair Laura Heise, Secretary Charles Ramos, Member Amy Meek, Member Frank Dunphy II, Member Mark Barroso (remote), Director Pandora Paschal, Deputy Director Steve Simos (remote), Election Specialist Chance Mashburn and temp employee Donald Lyerly. Secretary Charles Ramos led everyone in a moment of silence and the Pledge of Allegiance to the flag.

Call to Order

Chair Laura Heise called the meeting to order at 5:30 p.m. and welcomed the public. She stated that a quorum was present at this meeting. She also explained why we were not wearing mask because of the new CDC guidelines, and that everyone in the room was fully vaccinated. Citizens were invited to make comments through the chat feature.

Approve Minutes

Chair Heise asked if there were any additions or corrections to the minutes. There were none. Secretary Charles Ramos made the motion to approve the minutes. Member Amy Meek seconded the motion. All were in favor (Unanimous vote).

Public input

Chair Heise asked if there were any public input for this meeting. There were three public comments received from citizens to be addressed.

1. Republican Party Chair Terry Schmidt – Please address how temporary workers for early voting and for the MAT teams are selected for employment by Chatham County. Election Specialist Chance Mashburn stated that early voting workers are hired as Temporary employees by the Board of Elections through the county. When they are hired party affiliation is not a factor, but when scheduling is done, we do take that into consideration for balance at the sites. They go through background checks the same as regular county employees. Director Pandora Paschal stated that we look at the poll

Chatham voters on that eighteen-day interval. Election Day is becoming a minority of voters.

Director Pandora Paschal stated that the hiring of early voting workers is something you will need to take up with the legislators because that is the law. Frank Dunphy II stated he saw nothing on the State Board of Elections website, the Chatham County Board of Elections website, and there is nothing documented about how to become a early voting worker. Director Pandora Paschal stated they are temporary employees. Frank Dunphy II stated he looked in the North Carolina election law book there is nothing in there about early voting workers. Director Pandora Paschal stated she would get more information on where it is found. This was a public input question, and we should not focus on discussing this tonight, this is just my opinion, but it is up to Chair Heise.

Chair Heise stated that she agrees with what Director Pandora Paschal said, and that Frank Dunphy II is bringing up a topic that we are not going to be equipped to deal with tonight nor we are not clear enough on what the law is. I think we should ask the staff to research this question and come back to us with it at our next meeting. I think it would be inappropriate for us to try and vote on something that would change the way we do things here without a little more information.

Member Frank Dunphy II responded that he wants to make sure this is an agenda item for the next meeting, and I have at least four motions that I was going to make tonight. Member Frank Dunphy II asked Chair Heise if she wanted the motions to be made tonight? Member Amy Meek stated that we do not know if they are legal. Director Pandora Paschal stated that this is the way we have been getting early voting workers since I have been here. I have been here for 17 years. These are the guidelines the state has asked us to use. I will get documentation for the next meeting. Frank Dunphy II stated he imposed to the body that the elections landscape is changing. Director Pandora Paschal stated that this is a conversation that you should have with the legislature this is law. Member Frank Dunphy II stated the law needs to be changed. Director Paschal stated that the Board of Elections duty is not to change the law.

Member Frank Dunphy II stated for the public who is listening, Election Day is becoming where the minority of voter's vote. The majority of voters vote at early voting and the eighteen days before the election, so the workers who interact with the voters should be approved by the voting members of this body. It should not be delegated, in my opinion to the Director and the Assistant Director. Director Pandora Paschal stated she was not saying that she disagreed, but currently this how the process works. Chair Heise said to get guidance from the State Board of Elections for better understanding of hiring early voting workers. Member Amy Meek asked if this matter could be tabled. Chair Heise agreed.

Oakland Precinct

Chair Laura Heise opened the discussion to merge Oakland Precinct which currently has 1,002 registered voters and currently vote at the Pittsboro Fire Station with Three Rivers Precinct which currently has 1,196 registered voters and currently vote at Liberty Chapel Church. The alternative Is to split Oakland Precinct at US 15-501 with the eastern half of Oakland going to the Three Rivers Precinct, and the western half of Oakland voters going to the Goldston Precinct. Three Rivers precinct would be called the Moncure Precinct and vote at Moncure Elementary School. The reason for the move from the fire station Is parking is not good, poll workers can't set up the night before because the trucks cannot be moved out of the bay and they vote in the bay. There are no other alternatives in Oakland. Johnny Shaw who is a resident of Oakland precinct stated he did not see a problem at the community center when they voted there, nor does he see a problem at the fire station where they currently vote. Donald Lyerly who is an Oakland Resident and a former Chief Judge at the Oakland Precinct stated that he understood how Johnny Shaw felt, but it was challenging setting up that site. Member Amy Meek stated that seems be the problem at all the fire stations. Director Pandora Paschal stated that is why we are looking for other spaces to vote. Secretary Charles Ramos stated every time he went to one of the polling places in a fire station, he always had an uncomfortable feeling.

Chair Heise asked the board if they were ready to move forward with a vote after hearing all points of view about the matter.

Amy Meek made the motion to split Oakland precinct along highway 15-501 with the eastern half of Oakland going to Three Rivers precinct, which will change to Moncure precinct. The polling place will be Moncure Elementary school. The western half of the Oakland precinct voters going to the Goldston precinct to vote at the Goldston Town Hall. Mark Barroso seconded the motion. All were in favor (Unanimous vote).

Bennett /Harpers Crossroads

The board considered the merger of the Bennett precinct with Harpers Crossroads. Bennett has a total of 779 voters and Harpers Crossroads has a total of 759, which would be a total of 1,538 voters. Bennett currently votes in the Bennett fire station which has the same barriers as other precincts that vote in fire stations. The board agrees it would be better to merge the two for safety, security, and efficiency in the elections process. Frank Dunphy II suggested the name Bennett Crossroads for the precinct. Director Pandora Paschal suggested Crossroad's precinct. There was no further discussion. Chair Heise asked for a motion to move forward with the merge. Amy Meek made the motion to merge Bennett precinct with Harpers Crossroads precinct. The precinct name will be Crossroad's precinct, and the polling place will be the Harpers Crossroads Community Center. Member Frank Dunphy II seconded the motion. All were in favor (Unanimous vote).

Deputy Director Steve Simos reminded the board members to please send any items for discussion to the Director to put on the agenda prior to each meeting. Chair Laura Heise asked for any motions made to be sent to other members prior to the meeting. Director Pandora Paschal stated she did not think that was a good idea because these motions would need to be discussed by the full board. If there is a topic for discussion at the meeting it would be fine to share with other members.

At the June meeting Director Pandora Paschal will provide information about how early voting workers are selected and hired, and how MAT teams are selected. Supporting documentation will be provided.

Secretary Charles Ramos made the motion to adjourn the meeting at 6:58 pm. All were in favor (Unanimous decision).

I am Phillip Gilfus, chair of the Albright Precinct Democrats. Our precinct met on Sat., May 15, and discussed (among other topics) the potential merger of our precinct with our eastern neighbor, Hadley. Those in attendance were enthusiastic about the proposed polling station change from the fire station to the Ruritan Club. The greater availability of parking, the ease of accessibility offered by the front covered porch, and the greater space for "electioneering" make the proposed change attractive. We support the proposal for this new Silk Hope precinct.

There were some questions about how this additional role for the Ruritan Club would make them more publically accessible or not, outside of election days, for precinct gatherings. We also wondered whether it might be premature to modify precincts before the county receives the official census numbers in the fall - wouldn't the Board be in a position to change precincts again after those numbers come in?

But on the broad proposal, we believe the proposed Silk Hope precinct offers a wide array of benefits for the voters in Albright precinct.




