LYING AND BEING IN WILLIAMS TOWNSHIP, CHATHAM COUNTY, NORTH CAROLINA

COMMENCING AT NCGS CORS STATION "JORDAN LAKE CORS ARP" HAVING NC GRID (NAD83/2011) COORDINATES OF NORTHING: 739,273.05' & EASTING: 1,989,789.68'; THENCE N23°44'28"E A GRID DISTANCE OF 19,490.43 FEET TO AN IRON PIPE SET (IPS) LYING IN THE NORTHEAST QUADRANT OF THE INTERSECTION OF US 15-501 AND JACK BENNETT ROAD HAVING NC GRID COORDINATES OF NORTHING: 752,026.86' & EASTING: 1,975,051.39'; THENCE A TIE LINE N 12°03'40"E FOR A DISTANCE OF 68.03' TO A RIGHT-OF-WAY MONUMENT (RWMON) AT THE INTERSECTION OF US 15-501 AND JACK BENNETT ROAD; THENCE ALONG THE NORTHERN RIGHT-OF-WAY LINE OF JACK BENNETT ROAD THE FOLLOWING SEVEN CALLS:
