After a review of the proposed changes, we offer the following comments for your use:

- 1. There is no anticipated updated TIA requirement regarding the 50 ft shift to the west of the proposed main driveway connecting to Jack Bennett.
- 2. Eliminate the new proposed westernmost driveway which would introduce new conflict points onto Jack Bennett between the main driveway and the signalized intersection. Continue to design and plan for an internal service to parcel #2.

The development team for the Vickers Bennett property on US 15-501 between Vickers Road and Jack Bennett Road reached out to me this morning with a modified access plan, and I wanted to run it by you to make sure you were okay with it and did not need any changes to the TIA or some kind of addendum. The attached site plan is the one that we were working off of in the TIA, but I have made some revisions [in red] to illustrate the access revisions. To summarize:

- The main access point on Jack Bennett will be shifted west by a short distance to allow for a straight connection through the site between Vickers and Jack Bennett
- The easternmost full access will be removed, but will come back to life as a RIRO access for the commercial property only.

Basically just wanted to make sure that the counts that we collected in October 2019 and used for the Vickers Bennett TIA were still viable for use for any traffic study within the area. Typically we would do new counts, but over the course of the past year with COVID, we have been able to use previously collected data within recent years and just project volumes to the existing year. Ultimately just curious if those October 2019 counts would be able to be used if we had a developer looking for a traffic study within the area?

As Vickers Rd is not planned for extension in the future (as far as currently known), and given the relatively low through volume on Vickers Rd we will consider a reduction of the right turn lane requirement from 100ft of storage to a 50ft taper into the site.
