Hi all,

I will add that I recall going out to this property in the fall of 2019 to survey the house. I had mailed the property owners a letter about my survey proje heard anything from them, but went out in search of the house. The photo attached is the same structure I saw that day. I honestly wasn't sure if it we or a related outbuilding. Because I wasn't sure, I did not photograph it. I added the home to my personal "homes no longer standing" list, noting that i house, it was so severely dilapidated it wouldn't be around much longer.

Unfortunately I don't know anything about the house, nor have I seen any other photos of it. I had it on my survey list because I saw it on the State His Preservation Office's map. I do recall reading about the 1917 tornado that swept through the area and jotted down that the kitchen and chimney of the house was damaged during it - I believe I saw that in the 2014 history of the Briar Chapel and George Gaston Herndon family. That's all I got!
