As a Chatham County resident who lives in Fearrington Village, I am very concerned about the rapid growth of developments in our area of the county. Specifically, I oppose rezoning to allow more development of the Fearrington Reserve community by Congruus. Not only will this mean more cleared land, more traffic but also more sewage, all of which already are significant problems in our section of the county.

As you already know, neither Briar Chapel nor Fearrington has safe sewage treatment. Residents of Briar Chapel have told you repeatedly of the sewage spills that endanger the health of their community. We have been walking on the pedestrian trails in Briar Chapel when showers of their "grey water" sprayed across us, apparently due to errant water sprayers. Surely, having contaminated water spraying on pedestrians is not safe.

In Fearrington, with the continued rapid development of new neighborhoods, we have increased sewer problems. As you know, Fitch does not treat the sewage but stores it in holding ponds and tanks, with the solid waste taken out by tanker truck every few weeks. I am Charles S. Brown, Jr. My wife, Renee A. Brown, and I reside at 638 Spindlewood, Pittsboro NC In Fearrington Village. We are writing **in opposition** to Congruus LLC, developers of the proposed Fearrington Preserve, proposal to include an additional 186 acres of land off Parker Herndon and Morris Roads within the boundaries of the Compact Community Ordinance.

Our objection to the requested CCO amendment is based on the Congruus's suggested connection to the Fearrington wastewater treatment facility. The Fearrington wastewater treatment is currently being upgraded. These modifications will improve treatment effectiveness but will not result in any increased treatment capacity in support of a wastewater collection and treatment facility from outside the current Fearrington facilities.
