

CHATHAM COUNTY

WHEREAS, the North Carolina Department of Transportation anticipates July 1997 an allocation of \$1,224,349 and remaining funds of \$115,182 from the previous Secondary Construction Program, a total of \$1,339,531 for Secondary Road Improvements in Chatham County for the forthcoming fiscal year. A public hearing was held on June 2, 1997 in the Chatham County Courthouse Annex on the expenditures of said funds:


WHEREAS, it is proposed to retain \$17,051 of the total allocation for overruns.
