WHEREAS, the Board believes that this is the most appropriate manner to schedule the meetings to conduct the public's business.


NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the County of Chatham, North Carolina that:



Please remember that any variation in this schedule could result in overtime and premium pay costs, for which funds have not been budgeted. For this reason, any adjustment or change in this holiday schedule must be approved in advance by me. After receiving such approval, should court be held on a scheduled holiday requiring some of your employees to work, the employees will be granted an alternate day off, plus holiday premium pay. Please contact the AOC Personnel Office if this occurs to determine who is eligible for holiday premium pay, and the procedures necessary to make appropriate payments.

Please inform all employees of this new schedule. In areas where an office or courthouse bulletin board exists, please display this schedule for the benefit of all employees.
