Program Updates

El Futuro – Sabrina Aguilar Simon

- 1 served in 21/22; Denise noted that creditable clients are not limited to referrals from justice-system partners
- Still serving clients virtually; Durham office is offering hybrid services as a gradual reopening strategy
- Signage at Chatham site has been fixed
- Will send out information on several community offerings
- MOs for 20/21: 9 served out of 25 estimated; all other goals met

<u>Haven House – Patricia Cardoso</u>

- No referrals from Chatham so far in 21/22
- Dr. Carolyn Pender Roche has signed the contract to do psych assessments; office is near Southpoint
- Received a new invoice from Dr. Rademacher for a youth served in June; accounting to be adjusted in ALLIES
- MOs for 20/21: 1 served out of 10 estimated for Wrenn House; same for Psych Assessments; all other goals met

Family Advocacy – Maria Soto

- Currently serving 9 youth; there were 12 carryovers from 20/21;
- Parenting classes, home visits, in-school services being conducted
- MOs for 20/21: 25 served out of 47 estimated; all other goals met

<u>Teen Court – Pablo Avendano</u>

- 4 new intakes in 21/22; 1 has been accepted; 3 pending
- Restorative justice circles continue; educational seminars being offered
- MOs for 20/21: 8 served out of 38 estimated; all other goals met

Community Service and Restitution – Travis Patterson

- 12 served in 21/22; 10 were carryovers from 20/21; 6 active
- 5 active worksites expected to grow
- MOs for 20/21: 32 served out of 65 estimated; all other goals met
