WHEREAS, the North Carolina Department of Transportation anticipates July, 1996 an allocation of \$1,186,349 and remaining funds of \$47,684 from the previous Secondary Construction Program, a total of \$1,234,033 for secondary road improvements in Chatham County for the forthcoming fiscal year.
