EXTRACTS FROM MINUTES BOARD OF COMMISSIONERS

At a special meeting of the Chatham County Board of Commissioners held in the District Courtroom in the Courthouse Annex in Pittsboro, North Carolina at 7:00 o'clock p.m. on March 29, 1995 with Commissioners Dunlap, Grimes, Holland, Pollard and Wilson present, the following proceedings were had:

* * * *

The Clerk to the Board of Commissioners reported to the Board of Commissioners that the bond order entitled, "BOND ORDER AUTHORIZING THE ISSUANCE OF \$5,300,000 SCHOOL BONDS OF THE COUNTY OF CHATHAM," which had been introduced on March 20, 1995, had been published in a qualified newspaper on March 23, 1995, with notice that the Board would hold a public hearing thereon on March 29, 1995. The Clerk also reported that the County's Finance Officer had filed in the Clerk's office a statement of debt complying with the provisions of The Local Government Bond Act and such statement as filed showed the net indebtedness of the County to be 2.326 % of the appraised valuation of property in said County subject to taxation.

Commissioner Dunlap moved that the Board of Commissioners proceed to hold a public hearing on the school bond order. The motion was seconded by Commissioner Pollard and was unanimously adopted.

At ___7:20__ o'clock, _P.M., the Chairman of the Board of Commissioners announced that the Board of Commissioners would hear anyone who wished to be heard on the questions of the validity of the school bond order and the advisability of issuing the bonds. At the direction of the Chairman of the Board of Commissioners, the Clerk to the Board of Commissioners read said bond order and the published notice of hearing.

After the Board of Commissioners had heard all persons who requested to be heard, Commissioner Pollard moved that the public hearing be closed. The motion was seconded by Commissioner Wilson and was unanimously adopted.

Commissioner Wilson moved that the Board of

Clerk to the Board of Commissioners to publish as prescribed by

The Local Government Bond Act the bond order entitled, "BOND

ORDER AUTHORIZING THE ISSUANCE OF \$5,300,000 SCHOOL BONDS OF THE

COUNTY OF CHATHAM," introduced at the meeting of the Board of

Commissioners held on March 20, 1995. The motion was seconded by

Commissioner Dunlap and was adopted by the following vote:

Commissioner Pollard moved the adoption of the following resolution which was read at length to the Board:

WHEREAS, the Board of Commissioners of the County of Chatham has adopted the bond order hereinafter described authorizing the issuance of \$5,300,000 School Bonds, and such bond order and the indebtedness to be incurred by the issuance of such bonds and the tax to be levied for the payment of such bonds should be submitted to the voters of the County of Chatham for their approval or disapproval in order to comply with the Constitution and laws of North Carolina; NOW, THEREFORE,

BE IT RESOLVED by the Board of Commissioners of the County of Chatham, as follows:

- (1) The questions whether the qualified voters of the County of Chatham shall approve or disapprove (a) the indebtedness to be incurred by the issuance of the bonds of the County authorized by said bond order, which indebtedness shall be secured by a pledge of the County's faith and credit, (b) the levy of a tax for the payment thereof, and (c) said bond order shall be submitted to the qualified voters of said County at an election to be held in said County on May 23, 1995.
- (2) The Clerk to the Board of Commissioners is hereby authorized and directed to publish a notice of said election which shall be in substantially the following form:

THE COUNTY OF CHATHAM, NORTH CAROLINA NOTICE OF SPECIAL BOND ELECTION

NOTICE IS HEREBY GIVEN that a special bond election will be held in the County of Chatham, North Carolina, on May 23, 1995, for the purpose of submitting to the qualified voters of said County the questions whether they shall approve or disapprove (1) the indebtedness to be incurred by the issuance of bonds of said County of the maximum principal amount of \$5,300,000, which indebtedness shall be secured by a pledge of the County's faith and credit, and (2) the levy of a tax for the payment of such bonds, and (3) the bond order entitled, "BOND ORDER AUTHORIZING THE ISSUANCE OF \$5,300,000 SCHOOL BONDS OF THE COUNTY OF CHATHAM," adopted by the Board of Commissioners to authorize the issuance of said bonds and the levy of such tax.

The \$5,300,000 School Bonds are authorized to pay capital costs of providing school facilities and improvements in the Chatham County School Administrative Unit, including the construction of new schools and the renovation and expansion of existing school facilities, and including the acquisition and installation of necessary furnishings and equipment and the acquisition of land or rights-in-land required therefor.

The ballots to be used at said election shall contain the words, "SHALL the order authorizing \$5,300,000 bonds secured by a pledge of the faith and credit of the County of Chatham to pay capital costs of providing school facilities and improvements in the Chatham County School Administrative Unit, including the construction of new schools and the renovation and expansion of

existing school facilities, and including the acquisition and installation of necessary furnishings and equipment and the acquisition of land or rights-in-land required therefor, and a tax to be levied for the payment thereof be approved?", with squares labelled "YES" and "NO" beneath or beside such words in which squares the voter may record his choice.

In the event a majority of the qualified voters voting at said election vote to approve the order, the incurring of indebtedness and the levy of a tax related thereto, said bonds authorized thereby shall be issued and taxes shall be levied for the payment of such bonds.

The polls for the election will open at the hour of 6:30 o'clock, A.M. and will close at the hour of 7:30 o'clock, P.M. The precincts and polling places for the election will be as follows:
