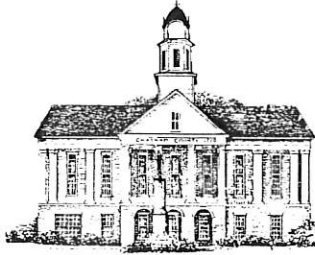

## RESOLUTION FIXING THE TIME AND PLACE OF ITS REGULAR MEETINGS FOR CALENDAR YEAR 1996

**WHEREAS**, G. S. 153a-40 provides the manner by which the Board of Commissioners may establish regular meeting dates; and

**WHEREAS**, in order that the Board, staff and public may plan as far in advance as is practical and reasonable the Board of Commissioners has deliberated the establishing of a meeting schedule for calendar year 1996; and

**WHEREAS**, the Board believes that this is the most appropriate manner to schedule the meetings to conduct the public's business.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the County of Chatham, North Carolina that:

**SECTION 1.** The meeting schedule shown as Attachment A to this resolution shall be the official schedule of regular meetings for the Chatham County Board of Commissioners for calendar year 1996.


