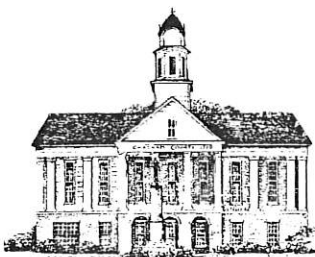

## RESOLUTION

### Authorizing Improvements to Earl Thompson Recreation Field

**WHEREAS**, the Land and Water Conservation Fund Act of 1965 provides for the making of grants by the National Park Service, Department of the Interior of the United States Government, to states and to local municipalities in the support of outdoor recreation projects, and such funds are available after approval of the appropriate state agency and the Department of Interior; and

**WHEREAS**, the State is required to insure that there will be no discrimination against any person of any race, color, sex, creed, or political affiliation; and

**WHEREAS**, the Board of Commissioners of the County of Chatham realizes that recreation facilities are not adequate to meet the minimum recreational needs of the people of Chatham County; and

**WHEREAS**, it is believed that said Board, with the assistance of the general public, is now in a position to lend full support to improvements to the Earl Thompson Recreation Field.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the County of Chatham, North Carolina, that:

**Section 1:** An application be made to the National Park Service, Department of the Interior of the United States Government, through the State of North Carolina, for a development grant of \$14,550.35, which represents 50 percent of all costs (\$29,170), including preparation, plans, and construction of recreational facilities to be completed in fiscal years 1994-95 and 1995-96.

**Section 2:** That the Chairman of the Board of Commissioners of Chatham County be authorized and directed to file such application on behalf of the County of Chatham, to provide additional information, and furnish such documents as may be required by the national Park Service and the State of North Carolina, and to act as the authorized correspondent of the County of Chatham.

**Section 3:** That the Director of the National Park Service, Department of the Interior of the United States Government, be and hereby is assured of full compliance by the applicant with the regulations promulgated pursuant to Title VI of the Civil Rights Act of 1964.


I move the adoption of the foregoing resolution.


