Activities scheduled for the FY 94 Chatham County Community Development Program include:

- Develop fair housing brochure that summarizes the fair housing requirements under Title VIII of the Civil Rights Act of 1968. (February 1995)
- Prepare a newspaper article which will be targeted for all citizens. The article will summarize fair housing requirements under Title VIII of the Civil Rights Act of 1968.
   The article will also inform citizens of the housing discrimination complaint procedures. (August 1995)
- Prepare a poster for distribution and posting. The poster will summarize fair housing requirements under Title VIII of the Civil Rights Act of 1968. The poster will also inform citizens of the housing discrimination complaint procedures. (November 1995)
- Develop a survey to assess past efforts, present knowledge, and status of fair housing efforts in the County. (February 1996)
- Assess the status of the County's fair housing activities for future actions. The assessment will be compiled and transmitted to the County for further actions. (May 1996)

Upon receiving a housing discrimination complaint, the County shall inform the North Carolina Human Relations Commission (Commission) and the complainant about the complaint within ten (10) calendar days of receipt. The County shall then assist the Commission and the complainant in filing an official written housing discrimination complaint with the Commission, pursuant to the State Fair Housing Act and Title VIII;
  - 3. The County shall offer its assistance to the Commission in the investigation and conciliation of all housing discrimination complaints which are based upon events occurring in Chatham County, North Carolina.
  - 4. The County shall publicize within Chatham County, North Carolina, that it is the local agency to contact with housing discrimination complaints.

The County will develop and disseminate the above Fair Housing Complaint Procedure. The public will be informed through hand-outs, educational materials, posters, and newspaper article(s).
