A RESOLUTION AUTHORIZING NOTICE OF INTENT TO INSTITUTE AN ACTION TO CONDEMN PROPERTY

WHEREAS, Chatham County intends to improve its solid waste collection and disposal system to serve residents within the County and including Albright Township, Chatham County, North Carolina, by the construction and operation of convenience centers for collection of solid waste, more particularly described in plans now on file in the office of the County, and to accomplish this purpose the County requires a site for a convenience center; and

WHEREAS, G.S. 40A-3(b)(2) and G.S. 153A-274(1) authorize the County to acquire property by eminent domain for such purpose, and G.S. 40A-40 requires that notice of the County's intent to institute an action for said purpose be provided to each owner at least 30 days prior thereto;

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE COUNTY OF CHATHAM RESOLVE:

1. A general description of the tract or parcel of land which property rights are to be acquired as follows:

certain parcel of land containing approximately 2 acres located east just Crutchfields Crossroads bounded on the South by N.C.S.R. 1346, on the West by the property of now or formerly John Duncan and Cindy Duncan and Willard Hinshaw, beginning at a point in the northern boundary of NCSR 1346, the southeast corner of the property of now or formerly John & Cindy Duncan, thence northerly with line of said Duncan and now or formerly Willard Hinshaw 440 feet, thence easterly, perpendicular to said line a thence distance of approximately 220 feet, southerly parallel to the first line to the northern right of way line of SR 1346, thence westerly along the northern right of way line of

said road to the point of beginning, as shown upon sketch attached hereto and designated as Exhibit "A".

- 2. The nature of the right, title or interest to be acquired in the property is a fee simple interest therein.
- 3. This property is to be acquired by the County of Chatham for the purpose of constructing, operating and maintaining a convenience center for collection of solid waste in connection with the Chatham County solid waste collection and disposal system.
