A RESOLUTION AUTHORIZING NOTICE OF INTENT TO INSTITUTE AN ACTION TO CONDEMN PROPERTY

WHEREAS, Chatham County intends to improve its solid waste collection and disposal system to serve residents within the County and including Williams Township, Chatham County, North Carolina, by the construction and operation of convenience centers for collection of solid waste, more particularly described in plans now on file in the office of the County, and to accomplish this purpose the County requires a site for a convenience center; and

WHEREAS, G.S. 40A-3(b)(2) and G.S. 153A-274(1) authorize the County to acquire property by eminent domain for such purpose, and G.S. 40A-40 requires that notice of the County's intent to institute an action for said purpose be provided to each owner at least 30 days prior thereto;

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE COUNTY OF CHATHAM RESOLVE:

- 1. A general description of the tract or parcel of land which property rights are to be acquired as follows:
 - a) That area in bold lines shown upon Exhibit "A" hereto as "Proposed Site" and
 - b) A non-exclusive easement 60 feet in width from U.S. Highway 15-501 to the "Proposed Site."
- 2. The nature of the right, title or interest to be acquired in the property is a fee simple interest therein as to so much of the proposed site as lies within the bold lines shown upon Exhibit "A", subject however to a private road

easement. As to the easement from U. S. Highway 15-501 to said Proposed Site, only a perpetual and assignable easement for access and for installation, maintenance and replacement of utilities to serve the proposed site.

- 3. This property is to be acquired by the County of Chatham for the purpose of constructing, operating and maintaining a convenience center for collection of solid waste in connection with the Chatham County solid waste collection and disposal system.

- 6. The date the County of Chatham intends to take possession of the property and to institute an action to
