


FEARRINGTON P.U.D., SECTION X, REMAINING UNDEVELOPED LAND AREAS

Re: Fearrington P.U.D., <u>Section X, Sketch Plan Revision</u> Request for New Street serving Properties South of Fearrington P.U.D.

Fearrington Village PUD was approved in 1976 as the first PUD in Chatham County and is now one of the larger communities in the County with over 3,000 residents and several hundred people employed in the services and businesses within the Village. **Fearrington P.U.D. is reviewed under the Pre-2008 rules.**

There are several reasons for this request:

Sketch Plan Approval is required for Re-alignment of proposed future street (<u>Granville</u>) that will provide P.U.D. required emergency access and utilities extensions easement to Riggsbee and Fitch Creations, Inc. properties south of the P.U.D. property line.

Fearrington requests that the <u>existing 20' easement</u> to the (2) properties south of Fearrington P.U.D. <u>be increased to 50' wide</u> to allow a future street south to Fitch Creations' owned land and emergency access and utilities extension easement(s) to Riggsbee if and when requested.

We feel that this new street right-of-way will improve emergency access and utilities opportunities for both the Fitch Creations property and for the Riggsbees' property. It will allow the Village to grow by one neighborhood.
