Resolution of the Chatham County Board of Commissioners

Approving MRF Western Intake Partners Regional Water Treatment Plant Grant Application

WHEREAS, The Federal Clean Water Act Amendments of 1987 and the North Carolina the Water Infrastructure Act of 2005 (NCGS 159G) have authorized the making of loans and grants to aid eligible units of government in financing the cost of construction and studies of Western Intake Partners, and

WHEREAS, The County of Chatham has the need for and intends to participate in three interdependent regionalization studies related to a regional new water treatment facility on Jordan Lake and associated water transmission pipeline infrastructure. The studies would evaluate technical alternatives, cost and economic feasibility, and partnership governance, and

WHEREAS, The County of Chatham intends to request State grant assistance for the project,

NOW THEREFORE BE IT RESOLVED, BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF CHATHAM:

That the County of Chatham, the Applicant, will arrange financing for all remaining costs of the project, if approved for a grant award.

That the Applicant will adopt and place into effect on or before completion of the project a schedule of fees and charges and other available funds which will provide adequate funds for proper operation, maintenance, and administration of the system and the repayment of all principal and interest on the debt.

That the governing body of the Applicant agrees to include in the loan agreement a provision authorizing the State Treasurer, upon failure of the County of Chatham to make scheduled repayment of the loan, to withhold from the County of Chatham any State funds that would otherwise be distributed to the local government unit in an amount sufficient to pay all sums then due and payable to the State as a repayment of the loan.

That the Applicant will provide for efficient operation and maintenance of the project on completion of construction thereof.

That Dan Lamontagne, Chatham County Manager, the Authorized Official, and successors so titled, is hereby authorized to execute and file an application on behalf of the Applicant with the State of North Carolina for a grant to aid in the study of or construction of the project described above.

That the Authorized Official, and successors so titled, is hereby authorized and directed to furnish such information as the appropriate State agency may request in connection with such application or the project: to make the assurances as contained above; and to execute such other documents as may be required in connection with the application.

That the Applicant has substantially complied or will substantially comply with all Federal, State, and local laws, rules, regulations, and ordinances applicable to the project and to Federal and State grants and loans pertaining thereto.
