The site is a 20.35-acre parcel located at the end of Hawk Point Road in Chatham County. The parcel is currently zoned R-1. The land is mostly forested with no building and/or structures on the site. Pokeberry Creek, a tributary to the Haw River, runs through the eastern side of the property. Our project does not encroach in the Regulatory Floodplain/ Floodway as shown on FIRM Panel 3710976500K.

The proposed project involves the extension of Hawk Point Road and the addition of a cul-de-sac near the western property line of Parcel 95254. For this project, clearing on the site will be limited to the area needed for construction of the cul-de-sac, an access easement to the Parcel 95254 and any associated storm water structures.



The North Carolina Natural Heritage Program (NCNHP) appreciates the opportunity to provide information about natural heritage resources for the project referenced above.

Based on the project area mapped with your request, a query of the NCNHP database indicates that there are no records for rare species, important natural communities, natural areas, and/or conservation/managed areas within the proposed project boundary. Please note that although there may be no documentation of natural heritage elements within the project boundary, it does not imply or confirm their absence; the area may not have been surveyed. The results of this query should not be substituted for field surveys where suitable habitat exists. In the event that rare species are found within the project area, please contact the NCNHP so that we may update our records.

The attached 'Potential Occurrences' table summarizes rare species and natural communities that have been documented within a one-mile radius of the property boundary. The proximity of these records suggests that these natural heritage elements may potentially be present in the project area if suitable habitat exists. Tables of natural areas and conservation/managed areas within a one-mile radius of the project area, if any, are also included in this report.


