Teen Court – Michelle Carey and Ronnie Dunevant

• Have not received any referrals, yet; may have found some workspace in the 1st Baptist Church of Siler City

<u>Wrenn House – Patricia Cardoso</u>

• No referrals from Chatham for FY 21/22; questions about the referral process - please contact Patricia or Kelsey

Psychological Assessments – Patricia Cardoso

- Received and completed 3 referrals for FY 21/22; 1 referral came in on last day of FY and will be applied to 22/23
- Has capacity for 6 assessments per year; have moved from paper to digital
- Dr. Pender has given a quote for adding an interpretive meeting with the family; Spanish interpretation would add to this cost; it would be about \$131 per hour

Community Service and Restitution – Travis Patterson

- 52 served in FY 21/22 with 36 successful terminations and 11 still active
- JMHS Athletic Department recently added as a partner
- Travis is moving from CSR to the High School Success Coach position at CIS

Family Advocacy – Maria Soto

- 34 served in FY 21/22 with 20 successful terminations and 7 unsuccessful; 7 active cases
- Veronica Nuñez is moving from FA to the CIS Mentoring Program; CIS is looking to hire a bilingual program assistant

<u> Teen Court – Tych Cowdin</u>

- 26 served in FY 21/22; only 4 were terminated unsuccessfully; all referrals were terminated by 6/30/22
- Backpack purchases (from last FY budget revision) were a big hit
