Membership

Committee work

Continuum of Services review

- The Risks and Needs Committee also worked to update the Continuum of Services document; with input from the today's meeting attendees, several more changes were made today, as well
- George pointed out that lists of substance abuse and mental health services are also maintained on the county website under the Public Health Department's tab

Program Updates

Teen Court – Michelle Carey

- Measurable objectives estimated to serve, 40; actual served to date, 2
- not a SPEP program, so no PEP
- First Teen Court held in the historic courthouse on December 6th with 2 cases; more referrals are in the pipeline
- Most referrals are from one SRO at Northwood, some from DJJ
- Have advertised for a program assistant but have not found a suitable fit yet; please spread the word

Wrenn House - Amy Spalding

- Measurable objectives estimated to serve, 10; actual served to date, 1
- Not a SPEP program but a limited PEP was shared with the Council

Psychological Assessments - Amy Spalding

- Measurable objectives estimated to serve, 10; actual served to date, 2
- No referrals for several months; last referral was July
- Not a SPEP program but a limited PEP was shared with the Council

<u>Community Service and Restitution – Tych Cowdin</u>

- Measurable objectives estimated to serve, 60; actual served to date, 26
- Currently have 8 worksites in Siler City, 6 in Pittsboro, and the Siler City Salvation Army will be added soon
- Tych will coordinate thank you notes to the worksites
- PEP was shared with the Council

Family Advocacy – Maria Soto

- Measurable objectives estimated to serve, 35; actual served to date, 14
- Continuing to do home visits and one-on-one parenting classes
- PEP was shared with the Council

DPS / DJJ Update

Juvenile Justice Statistics

- Limited availability due to software limitations
- 13 complaints in December, 1 was referred to court, 8 were closed, and 5 were diverted, no detentions

Area Consultant

- 3rd quarter accounting is coming soon
- There is a possibility of discretionary money becoming available in the months to come
- A Resolution regarding DJJ critical understaffing in general will be submitted to the Chatham Commissioners

Other Business / Announcements

- George gave an update on the opioid settlement funds; still looking for the right hire to coordinate the program
- The team brainstormed on how to increase referrals from SROs
- The School Board has approved the School Justice Partnership
- Chatham County Schools is sponsoring an online parent seminar on vaping on January 24th, at 6:30
- Chatham Drug Free will host events on 01/14 at the JM vs Northwood game and on 1/27 for the Seaforth and Chatham Central game. They will have prizes and 360 photo booth; kids can get free admission tickets and concessions
