# **Close Polls on Early Voting Verity Scan**

The polls will be closed, and the tapes will be printed. Results will not be released until 7:30 pm when the precincts close and results will be released to the public.

### **Complete Tally Sheets and Absentee Abstracts**

The board tallied the votes for each contest from the tapes produced by each of the three Verity Scanners and the total absentee ballots cast for this meeting. The unofficial total was 559. The board signed the abstracts in triplicates to send to the North Carolina State Board of Elections, the Clerk of Court, and a copy for the office. A copy will be sent to the Town of Cary.
