#### **Finalize Results**

There will be a runoff for the Cary Town Council District D seat on November 7, 2023. Voter history was finalized. The total ballots cast, and the total voter history were the same. Member Lindemann made the motion to accept the official results for the October 10, 2023, Town of Cary Election. Member Tyson seconded the motion. All were in favor. Vote 5-0.

#### **Sign Canvass Abstracts**

The board signed abstracts with the official results for the October 10, 2023, Town of Cary Election. Copies will be sent to the North Carolina State board of Elections, the Clerk of Court, and the Town of Cary.
