As shown on the attached Existing Condition plan, the existing cross pipe underneath the road is a 15", and the entire downstream run is 15" RCP. This is shown on the attached Grading Plan. JB-1 will connect the new storm pipe to the existing 15" storm pipe, which runs north to an existing pond.

Does the new cross pipe have to be 18" even though it is replacing a 15" and will connect to an existing 15"? And does this grading plan appropriately address the comment about showing what JB-1 ties to and where it outlets?

### NCDOT plat review comments:

- Hike/Bike trail is drawn over the proposed ROW; on the plat, we would like to see that trail end at each of the ROW lines.
- The 20' drainage easement should be called out as Permanent Drainage Easement or PDE.
