Hi Genie,

As I explained I explained in an email to Old North State Water, the CE Group and Triangle Site Design back in May, in order for the Briar Chapel Wastewater Treatment Plant permit to potentially be modified to accept wastewater from a car wash, a pretreatment ordinance would need to be submitted and approved. The permit then may potentially revised. Then, before Sam's Xpress can be connected, you would need to complete an Industrial Wastewater Survey (Long Form) to demonstrate that the wastewater will be equivalent to domestic wastewater. I'll copy the language I sent back in May.

This will need to be submitted to our Non-Discharge Permitting Unit by Old North State Water, and ONSWC will have to request for their permit is modified. I have included staff of DWR's Non-Discharge Permitting who would be reviewing the submittal, and potentially modify the permit (Vivien & Nathaniel). They should be able to answer your questions about how to complete the Industrial Wastewater Survey.

Here's the language I sent in an earlier email:

- 1. A pretreatment ordinance needs to be submitted and approved that meets the conditions in the comment above (the comment states that this would be done prior to operation of the plant, so this should have already been done... and it might have been, but it will need to be provided again). See this link for an example of a Pretreatment SUO (particularly see Section 2.3): LINK
 - 2. The permittee would need to prove that the wastewater that will be discharged to the collection system and the WWTP would be equivalent to domestic wastewater. See Industrial Wastewater Survey (Long Form) here: <u>LINK</u>. Also see 15A NCAC 02U .0201(g) here: <u>LINK</u>

The pretreatment ordinance and the confirmation of domestic WW equivalency would need to be submitted to DWR's Non-Discharge Permitting unit (staff copied on this email). You should direct questions to them. Once approved, the sewer extension permits may be issued at that time. The permitting unit will also then consider modifying the WWTP permit to reflect this.
