

**SECOND AMENDMENT TO AGREEMENT**

This Second Amendment to the Agreement (this "Second Amendment") is made and entered into this 1<sup>st</sup> day of March, 2024, by and between Chatham County (the "County") and Green Revival Landscaping (the "Contractor").

**RECITALS**

- A. The County and the Contractor entered into the original Agreement effective the 1<sup>st</sup> day of July, 2022 (the "Agreement").
- B. The County and the Contractor entered into the First Amendment effective the 1<sup>st</sup> day of July, 2023.
- C. The County has requested that the Term of Agreement be extended to June 30, 2025.
- D. The Contractor has requested that the Compensation for the current Term of Agreement be increased by an additional \$18,400.00 and shall be in the amount of \$123,085.00 for the renewal term of this Third Amendment as shown in Appendix 1.
- E. The County and the Contractor has agreed to amend the Agreement as requested.

NOW, THEREFORE, in consideration of the mutual covenants and the conditions contained herein, the Parties agree as follows:


- 1. The Term of Agreement is extended to June 30, 2025.
- 2. The Compensation is increased for the current Term of Agreement by an additional \$18,400.00 and shall be in the amount of \$123,085.00 for the renewal term of this Third Amendment as shown in Appendix 1.

AGREEMENT TO REMAIN IN FULL FORCE AND EFFECT. Except for the amendments set forth above, the original Agreement of July 1, 2022, shall remain in full force and effect.
