Enclosed please find one copy of the "Application for Approval..." together with one copy of the referenced engineering plans bearing the Division of Water Resources stamp of approval for the referenced project. These engineering plans are approved under Division of Water Resources Serial Number 24-00126, dated July 12, 2024.

Engineering plans prepared by David E. Whittington, P.E., call for the installation of approximately 290 feet of 12-inch water main, 17,050 feet of 8-inch water main, 630 feet of 4-inch water main, fire hydrants, blow off assemblies, valves, and appurtenances along Park Meadows Drive, Parkway Drive, and Roads A – J to serve 453 residential units (309 single-family lots and 144 townhome units) within Phases 2A, 2B, 3 and 4 of the Parks at Meadows Drive well connect to the existing 12-inch water main at the roundabout with The Parks Drive and the proposed 8-inch water main along Parkway Drive will connect to the existing 12-inch water main at the roundabout with The Parks Drive and the proposed 8-inch water main along Parkway Drive will connect to the intersection with The Parks Drive. The project will be completed in four phases: Phase 2A will include lots 323-328 and 365-373 along Roads G, Phase 2B will include lots 201-215, 329-364, and 374-453 along Roads A, G, H, I and J, Phase 3 will include lots 158-200 and 216-322 along Roads A, E, F, and I, and Phase 4 will include lots 1-157 and 162-166 along Roads A, B, C and D. Construction of this project must be in accordance with Aqua North Carolina, Inc.'s standard specifications.

Upon completion of this project, the Chapel Ridge S/D water system has a bulk water purchase agreement with the Town of Pittsboro (NC0319015) to serve a total of 2,100 connections; (1) 500,000-gallon elevated storage tank, and distribution to serve up to 1,800 connections.
