### FIRST AMENDMENT TO AGREEMENT

This First Amendment to the Agreement (this "First Amendment") is made and entered into this 18<sup>th</sup> day of December, 2023, by and between Chatham County (the "County") and All Pro Painting (the "Contractor"). The County and the Contractor are sometimes referred to in this Amendment individually as a "Party" and collectively as the "Parties."
