#### LICENSE AGREEMENT - BULK COLLECTIONS

#### **Clothing Bins**

THIS LICENSE AGREEMENT ("LICENSE") is made and entered into this <u>May 28, 2024</u> by <u>Chatham County Solid Waste & Recycling</u> ("Licensor") and granted to <u>Green Zone Recycling LLC</u> ("Licensee").

- 1. Subject to the conditions set forth herein, Licensee is hereby granted an EXCLUSIVE LICENSE ("LICENSE") to place and operate the Donation Bin/s at business commonly known as: **Chatham County Collection Centers (See Exhibit B)** in the location indicated on the site plan, attached hereto and made a part hereof as Exhibit "A". Licensee, at its sole cost and expense, shall obtain all necessary government approvals and permits for the use of the Donation Bin/s. The approval and operation of the Donation Bin/s shall not cause Licensor to be in non-compliance with any governmental requirements or require Licensor to make any changes to the Facility.
- 2. This LICENSE shall commence effective <u>July 1, 2024</u> and terminate on <u>June 30, 2025</u>. Licensee shall pay to Licensor a **Flat** fee of **\$0.10** per pound of collections. Licensee shall make payment to Licensor based on the report of total weight collected after each **Month**. In the event of termination by Licensor, any fees paid in advance which are applicable to the period subsequent to the termination date shall be refunded to Licensee upon removal of the Donation Bin/s. Additionally, Licensor agrees to provide Licensee with the Right of First Refusal. The Right of First Refusal shall exist for the term of the LICENSE AGREEMENT and will be automatically renewed. In the event Licensor is approached by another organization to place Donation Bin/s used for the collection of textiles, Licensee shall be given an opportunity to renegotiate its LICENSE with Licensor prior to termination.
- 3. Licensee shall promptly comply with all laws, ordinances and regulations affecting the Donation Bin/s and the cleanliness, safety and use of same. Licensee shall be responsible to maintain the Donation Bin/s in a first-class manner and not perform any acts or carry on any practices that may injure any person or property or be a nuisance to the tenants and customers in the Shopping Center. The Donation Bin/s will be serviced and maintained, at minimum on a weekly basis, or more often if necessary. Licensee shall maintain the cleanliness and professional appearance within 10ft around the Donation Bin/s. Licensee shall assign and maintain a sales representative to the Licensor, throughout the term of the License. A sales representative will be available 24/7 to return all calls within 30 minutes. Any and all issues with the Donation Bin/s will be resolved within 4 hours after notification to assigned sales representative. If Licensee fails to maintain its obligations under this License, and/or if Licensee fails to remove Donation Bin/s upon termination of the License by either party, Licensor has the right to dispose of Donation Bin/s and its contents without any liability to the Licensee. Licensee is prohibited from advertising in any manner on the outside or around the Donation Bin/s, other than Licensee's company information.
- 4. Licensee shall, with respect to License's use of the Donation Bin/s, procure and keep in effect during the term a policy or policies of commercial liability insurance in the amount of at least Two Million Dollars (\$2,000,000.00) combined single limit for bodily injury (including death) and property damage in any one occurrence. Licensor shall not be responsible or liable to the Licensee for any loss or damage that may be occasioned by or through the acts or omissions of persons using or servicing the Donation Bin/s, whatsoever, other than solely by reason of the gross negligence or willful misconduct of Licensor.
- 5. Provided Licensee is not in default beyond any applicable cure period, Licensor agrees that Licensee shall be the only organization allowed in, at or on Licensor's property to place and operate the Donation Bin/s used for collection of textiles. In the event any Donation Bin/s belonging to other organizations are placed in, at or on Licensor's property without Licensor's permission, Licensor's requirement shall be to notify such organization, in writing, to remove the Bin/s. In the alternative, Licensor



may notify Licensee of such organization's presence and shall grant Licensee the authority to notify such organization that the organization's donation bins must be removed pursuant to this LICENSE. Additionally, Licensor shall grant Licensee written consent and express authority in the form of an Authorization Letter attached to this License to have any Bin/s removed. Licensor shall not be required to remove such. Licensee has the authority to remove any Bin/s not authorized if they are not removed after notification from Licensor.

- 6. Authority to remove any Bin/s is authorized by Licensor only during the active License Agreement. Licensee shall indemnify, defend and hold harmless Licensor, its officers, employees, agents, representatives, consultants, and contractors from and against any and all loss, costs, penalties, fines, damages, claims, expenses (including attorney's fees) or liabilities arising out of, resulting from, or in connection with the removal service.
- 7. All License Fees and other fees payable herein and all written notices required herein shall be mailed to Licensor at the address shown below until Licensee is otherwise notified in writing. All written notices required herein shall be mailed to Licensee at the address shown below until Licensor is otherwise notified in writing.

If exercised, the first option period will begin on <u>July 1, 2025</u> and terminate on <u>June 30, 2026</u>. The second option period will begin on <u>July 1, 2026</u> and terminate on <u>June 30, 2027</u>.
