

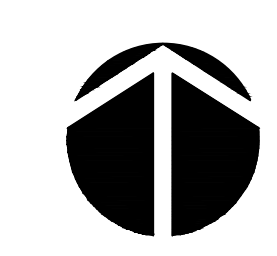
VICINITY MAP

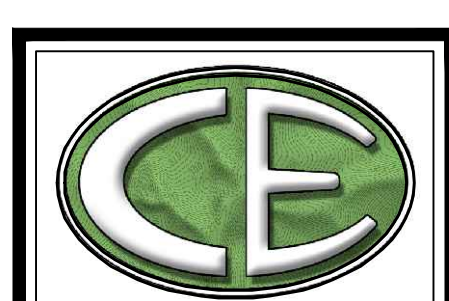
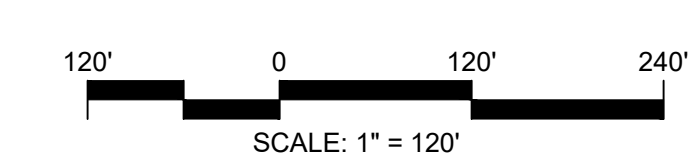
