ARPA 735 (revised 9/30/2024)

This Contract Amendment ("Amendment") is entered into on October 1, 2024, by and between **Chatham County** (" the Provider") and **Central Pines Regional Council's Area Agency on Aging** (" Central Pines" or "Area Agency") collectively known as "Parties."

WHEREAS:

- The Parties entered into a contract with an effective date of February 1, 2022, through September 30, 2024, for the purpose of administering **ARPA** (American Rescue Plan Act) funds ("Contract").
- The original term of the Contract was set to expire on September 30, 2024.
