FIRST AMENDMENT TO AGREEMENT

This First Amendment to the Agreement (this "First Amendment") is made and entered into this
day of Octobea, 2024 by and between Chatham County, a body politic and corporate of
the State of North Carolina (the "County") and Guardian Angels Home Care of North Carolina (the
"Contractor"). The County and the Contractor are sometimes referred to in this Amendment collectively
as the "Parties."

RECITALS

- A. The Parties entered into the original Agreement that commenced on October 1, 2023 (the "Agreement").
