- 1. **YMCA Proposal:** The YMCA has agreed to the proposal the Board of Commissioners has previously discussed regarding local government reduced membership for use of the YMCA.
 - A. Employees of Chatham County, Pittsboro, Siler City could use the Pittsboro facilities for a minimal amount; discussed was either \$5.00 or \$10.00 per month for direct employees and incremental increases \$5.00 per month for spouse and \$5.00 more for family;
 - B. We would do a one year pilot and see how it works and consider longer agreement if parties are satisfied with the arrangement at the time of review;
 - C. Chatham County would reduce the YMCA rent by \$1,000 per month;
 - D. The YMCA would use the revenue gained by rent reduction to pay off equipment loan and use the balance of the rent reduction to build their capital reserves for future building construction of a YMCA in Chatham County.

Commissioner Tom Vanderbeck moved, seconded by Commissioner Carl Thompson, to approve the YMCA proposal to allow the employees of Chatham County, Pittsboro, and Siler City to use the Pittsboro facilities for a fee per month of \$5.00 per employee, \$10.00 employee/spouse, \$15.00 family and to reduce the rent by \$1,000 per month.

- 2. Discussion of Potential Stimulus Money from NC Department of Transportation and potential funding options for transportation issues in Chatham County
- 3. Discussion and Approval of Local Agreement with DOT for Sidewalk Project on US Highway #15-501 North using Federal Stimulus Funds

Commissioner Tom Vanderbeck moved, seconded by Vice Chair Sally Kost, to approve the Local Agreement with the North Carolina Department of Transportation for the Landscape Project #STM-0015(28) on US Highway #15-501 North using Federal Stimulus Funds.

Commissioner Tom Vanderbeck moved, seconded by Commissioner Carl Thompson, to approve the Local Agreement with the North Carolina Department of Transportation for the Sidewalk Project #STM-0015(27) on US Highway #15-501 North using Federal Stimulus Funds.
